There are potential dangers lurking in your garden that may harm your cats! Make sure you're in-the-know about toxic lilies before it's too late.

TOXIC LILIES

ASIATIC LILIES

Spot an Asiatic lily by its characteristic leaves that radiate off a central stem. Asiatic lilies often have large, trumpet-shaped blooms in a wide range of colors. All parts of the plant are toxic to cats.



DAYLILIES

Similar looking to Asiatic lilies, the main difference in daylilies is the foliage, which appears almost grassy. All parts of the plant are toxic to cats, so be careful when planting daylilies in your garden.
